In March, the Mat-Su Health Foundation (MSHF) implemented a Coronavirus Prevention & Response (CPR) grant program to provide expedited support to the community. CPR grants helped organizations working to minimize exposure to high-risk groups, pay for supplies and program costs for agencies working to secure basic needs for all residents or offering activities to support Mat-Su youth, and fund operational support for organizations meeting basic needs or providing childcare. The foundation made CPR grants totaling \$1,629,805 and every member of our program team was actively engaged in working in the community to make sure resources got where they needed to be.

Youth 360 continued supporting Mat-Su youth in two cities (Houston and Wasilla) even when school closed to in-person education, allowing for virtual and outdoor pro-social connections during a difficult time of isolation. Youth 360 publicly debuted its data feedback loop in 2020 to share with parents how youth are reporting their mental health, connection and belonging to community, use of substances, experiences with bullying, volunteerism, time spent with family and more.

As part of our effort to build the healthcare workforce of tomorrow, MSHF awarded 83 vocational scholarships totaling \$289,836 and 336 academic scholarships totaling \$1,713,932. MSHF

also invested in the state's SHARP loan repayment program, adding significant capacity to the Mat-Su healthcare workforce.

MSHF's community resource center network Connect Mat-Su continued to grow. The program added four new staff members, expanded access to services and increased partnerships. In addition, Connect Mat-Su launched a website, connectmatsu.org, to offer a searchable database putting resources and information at the public's fingertips.

In response to a global call for racial equity, R.O.C.K. Mat-Su (Raising Our Children With Kindness) deepened its commitment to developing a localized racial equity curriculum. The workshop pivoted to a virtual platform, and 32 community members trained during the pilot phase with plans underway to fully deploy in 2022. The curriculum is now called Braided Stories: Building Equitable Communities for Alaska's Children & Families.

Thank you for climbing the mountain with us – let's continue to enjoy the view together!
